2 Social conflicts

Lewis Kozler as a social conflict theorist. The role of resentment in social conflict. The specifics of realistic and unrealistic conflicts. Constructive potential and functions of conflicts according to L. Kozler. Conflicts in closed and open societies. R. Darendorf as a theorist of social conflicts. Access to resources as a source of conflict. Levels of conflict unfolding according to R. Darendorf. Resolving social conflicts.

3 Force and violence in conflicts

Georges Sorel on force and violence. Analytical distinction between force and violence. The role of myth in the conflict (case: the role of myth in the general strike). The view of Zh. Sorel's view of the bourgeoisie and the class conflict. The myth in the class conflict. The phenomenon of national myths and their role in the political conflict. J. Sorel's attitude to Russian Bolshevism and Italian Fascism.

4 Major conflicts in politics

Political science understanding of the phenomenon of revolution: (neo)Marxist and neo-Weberian approaches. The subject of the revolution. Antonio Gramsci: intellectuals, culture, & revolution. Typology of revolutions. The revolution and the revolutionary dictatorship. Typology of Carl Schmitt's dictatorships.
